**Submission of Bid:**

The intending bidders shall have to deposit their rates in the tender box placed in the office. The vendor should be registered agency and should have experience in supplying similar products to any other Govt./ semi Govt /autonomous bodies for last 3 years.

- They should have a registered office in Kolkata.
- No bidder will be allowed to bid in proxy.
- No bidder who has a part or interest in another bidder will be allowed to bid.
- Cooperative Societies are requested to bid directly and not through agents.
- Bidder will have to submit Security Deposit of Rs. 5,000/- in form of Demand. ( Cooperative Societies will be exempted from submission of Security Deposit) Draft drawn from any nationalized bank valid for a period of not less than 120 days from the date of acceptance of work order.

Any violation of the above bidding requirements will result in cancellation of bid or non payment in case the deviation comes to notice .

Sealed envelopes clearly mentioning in super-scripting "Tender for Stationary article " should be dropped in the Tender box located at 4<sup>th</sup> Floor WBSCT&VE&SD office. The bid should be addressed to the CAO, WBSCT&VE&SD at above mentioned address on or before 14<sup>th</sup> January, 2022 at 2.00 p.m. This office shall not be responsible for any delay in postal transit. No bid shall be accepted after the due date and time.

Tender will be opened on the same day at 4<sup>th</sup> floor of KarigariBhavan at 4: 00 PM. **Terms and Condition :**

1. **The Bid Document should contain**
  - i. Self attested copy of Valid Trade License
  - ii. Self attested copy of PAN Card of Company
  - iii. Self attested copy of Professional Tax Clearance Certificate


- iv. Self attested copy of GST Registration Certificate
- v. Certificate of Credential of Similar Kind of Work from the previous /existing Institutions in support of eligibility Clause.
- vi. Last three years Income Tax returns of the Company.
- vii. Self Certified declaration that the Bidder satisfies the Bid clause mentioned in "Submission of Bid".

2. **Financial Requirement**

- 1) The rate quoted will have to be inclusive of all charges whatsoever.
- 2) The bidder will have to quote their rate in both in numbers and in word.
- 3) The Council reserves the right to cancel any or all the quotation if so required without assigning any reason thereof.

3. **Terms of Work**

Eligible bidder will have to make the supplies within 20 days of issuance of work order. If it is found that the supplies are not according to the specified quality the same will be returned with a scope to resupply within next 10 days. In case of failure to do the same or inability to make the whole supply within the specified period the Work Order will stand cancelled and the Security Deposit will be forfeited. The Council will then have the right to issue the Order against next lowest bidder.


